RULES

All amateur and professional photographers regardless of their nationality, **except GFAL partners may participate.**

1 – THEME

The competition will consist of three sections:

A - Monochrome

B - Color

C - Travel (monochrome and color)

You may submit up to 4 photographs by subject. The technique is completely free. You may not be presented the same picture on every issue, nor photographs presented in previous editions.

Authors who do not meet all the conditions of participation and / or have not made the payment of registration fees, their works will not be evaluated by the jury.

DEFINITION OF THE BLACK AND WHITE PHOTOGRAPHY (MONOCHROME) A black and white work fitting from the very dark grey (black) to the very clear grey (white) is a monochrome work with the various shades of grey. A black and white work toned entirely in a single colour will remain a monochrome work able to stand in the black and white category; such a work can be reproduced in black and white in the catalogue of a salon under FIAP Patronage. On the other hand a black and white work modified by a partial toning or by the addition of one colour becomes a colour work (polychrome) to stand in the colour category; such a work requires colour reproduction in the catalogue of a salon under FIAP Patronage.

DEFINITION OF TRAVEL PHOTOGRAPHY A Photo Travel image must express the feeling of a time and place, and portray a land, its distinctive features or culture in its natural state. There are no geographical limitations. Close-up pictures of people or objects must include distinguishable environment. Techniques that add to, relocate, replace or remove any element of the original image, except by cropping, are not permitted. All adjustments must appear natural. Conversion to full monochrome is acceptable. Derivations, including infrared, are unacceptable.



Only digital files are accepted.

The images will be in **jpg** format, whose maximum size is 3000 horizontally and not more than 2000 vertically with a resolution of 254 ppi, not exceeding 2 Mb. Recommending the **sRGB** color space.

The participants in the case to be rewarded or selected will send photos to print higher resolution if they are required for exposure are reminded.

The winning photographs will become property of the City Council for their library. It reserves the right to reproduce freely (catalogs, posters, press, reports, etc ...), non-profit and quoting the author's name / a.

Contestants certify the authorship of their works and are fully responsible that no rights of third parties and all claims for image rights of the works presented.
